1. OPENING AND ATTENDANCE:

2. **MATTERS**:

2.1. The Practitioner's view regarding the reasonable prospect of rescuing the entity:

The Business Rescue Practitioner confirmed that he has partly investigated the affairs of Wine Flies (Pty) Ltd (Under Supervision) (hereinafter the Company) and confirmed that the Company is in fact in financial distress, but that there is a reasonable prospect of securing a better return for the creditors in terms of Section 128(b)(iii) of the Companies Act 71 of 2008.

2.3. Determine whether or not a committee of creditors and/or employees should be

elected:

The Business Rescue Practitioner explained that creditors may elect a committee as

referred to in Section 147(1)(b) of the Companies Act. The affected parties present at the

meeting indicated that it would not be necessary to have a creditor committee. The

Business Rescue Practitioner will subsequently liaise with all affected persons directly.

3. **DATE OF NEXT MEETING:**

The meeting to determine the future of the Company in terms of Section 151 of the

Companies Act 71 of 2008 (herein after referred to as the "Act") will be convened after

publication of the Business Rescue Plan. Creditors will receive notice of the

aforementioned meeting timeously. Kindly refer to time frame below.

4. EXTENSION TO PUBLISH THE BUSINESS RESCUE PLAN:

The Business Rescue Practitioner did not request an extension for the publication of the

Business Rescue Plan, but reserved the right to do so in the event that it becomes

necessary.

The preliminary date for the publication of the Business Rescue Plan in terms of the Act

is 23 August 2021.

5. ADMINISTRATIVE PROPOSALS BY THE BUSINESS RESCUE PRACTITIONER:

5.1. Due to the fact that the Business Rescue Practitioner cannot foresee all scenarios during

the Business Rescue process and the fact that certain actions during the process may

influence the Business Rescue Practitioner's ability to adhere to the timeframes as set

out in the prescribed Act, the following was proposed:

5.1.1. That all future voting may take place via a proxy system as prescribed in the

Companies Act;

5.1.2. That any extension to publish the Business Rescue Plan in terms of Section 150

of the Act and specifically voting to extend the publication of the Business Rescue

Plan as referred to in Section 150 (5) (a) & (b), could be dealt with by means of

voting by email system. Voting will take place as referred to in Section 147(3) of

the Act.

5.2. It is minuted that the administrative arrangement as set out in Paragraph 5 above was

accepted by 100% of all creditors present at the meeting.

6. **NOTES:**

6.1. The preliminary time frame for the Business Rescue proceedings is:

23 August 2021 - Publish Business Rescue Plan

6 September 2021 – Second Creditors Meeting

6.2. The Business Rescue Practitioner urges creditors to submit their claims before Friday 20

August 2021.

6.3. The Business Rescue Practitioner is of the view that the company holds reasonable

prospect to be rescued, since the company is still trading, has access to infrastructure

and the relaxation measurements to curb the spreading of Covid, have allowed for

business activities to continue.
